### WPPBC Meeting Minutes – June 1, 2010

- Meeting called to order at 6:04 PM
- Old Business discussed
  - Ms. P. discussed results of Girls of the Golden Well box office. The play netted about \$3,000 profit which will enable the theatre to put on a fall musical now.
  - Ms. P. also made note that she is leaning towards doing a Dracula musical since the fall play dates will fall on Halloween this year. Mr. Schauer will again do a winter play and Ms. P. has not yet decided on a spring play for 2011.
- New Business discussed
  - Ms. P. described the three laptops that were donated through a grant to the theatre that she will be using to teach lighting and sound to her tech students. She already has the software, but needs a CD Rom drive to load the software in to the laptops.
  - A motion was made and seconded that the booster club purchase a CD Rom drive for the students. Mike Walters said he would purchase the CD Rom drive this week at Best buy for around \$50 and get it to Ms. P. before school ends this year.
  - Chairperson Mike Walters discussed the Girls of the Golden well DVD that is currently being finished by Bryce Vails. He hopes that the DVD will be available for sale at the Thespian Banquet on the 5<sup>th</sup>.
  - The booster club determined that the price of the DVD should be set at \$10.
  - Mike discussed the Girls of the Golden Well play-book and said it is complete and will cost \$18 for anyone wanting to purchase one. They should be available at the Thespian Banquet and are also available on-line through the booster website and Facebook.
  - Mike stated that a final deposit was made to the bank from ComedySportz's final match for about \$397 and that the current balance according to the bank was around \$3700. Bianca Hamblin/Treasurer will get with incoming Chair Beth Martin to balance the books prior to next school year.
  - Officer ballots for next year's booster club board were handed out and new officers were elected.

  - Outgoing Chairperson Mike Walters will need to be removed off the Booster Club Checking account as well as previous Vice Chair Mary Beth Miller who was not removed last year for some reason.
- Ms. P. made some comments about dry-cleaning needing to be done for the costumes for the year. She will coordinate with Mike Walters or Sherri Marcinov for help in transporting the costumes to and from the cleaners.
- Expense records for concessions were handed out showing the money earned for ComedySportz concessions for the year as well as Girls of the Golden Well
- Outgoing Chair, Mike Walters, stated that he was almost finished with the yearly Income & Expense statement and would get the data to newly elected Chairperson Beth Martin in a couple of weeks.
- All booster files, keys, and cash boxes were handed over to Beth Martin.
